2. **Dr. Tubagus Achmad Darajat, M.Pd.** : Represented Head of Master of Education, who hereby legally represents and acts for and on behalf of the Head of Master of Education, International College, Rajamangala University of Technology Krungthep, whose address is at Thung Maha Mek, Sathon, Bangkok 10120, Thailand, hereinafter referred to as **Party II**.

PARTY I and **PARTY II** hereinafter referred to collectively as **THE PARTIES**. The Parties hereby agree to jointly arrange an Implementation Agreement on the program **Academic Cooperation** Organized by **THE PARTIES** as regulated in the following articles. The activity is in accordance with the provisions of Memorandum of Agreement signed by **THE PARTIES** on **25 June 2025**.

- (2) **Party I** shall cover all travel, accommodation, and operational costs for activities conducted by **Party II**, which include attending and delivering a keynote presentation at the ICRITEE 2025 International Seminar held at Universitas Negeri Malang.
- (3) **THE PARTIES** shall monitor the implementation of the program **quarterly** not less than 2 (two) times in one period of activity.
- (4) **THE PARTIES** are to carry out **budget planning and activity evaluations** as stated in the attachment

FUNDING

The total funding for this collaboration is divided as follows:

- (1) **Party I** allocates funds for travel, accommodation, and operational costs for activities conducted by **Party II** at UM, sourced from the Faculty of Education's annual budget.
- (2) Any budget changes require mutual written agreement.

Article 6
Force Majeure

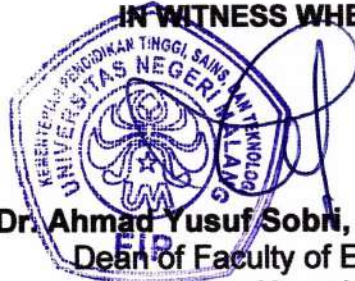
