

**MEMORANDUM OF UNDERSTANDING
BETWEEN
UNIVERSITAS NEGERI MALANG
MALANG, INDONESIA
AMERICAN COUNCILS FOR INTERNATIONAL EDUCATION
WASHINGTON, D.C., USA
AND
THE UNIVERSITY OF WISCONSIN-MADISON, USA**

The following Parties, the Universitas Negeri Malang (hereinafter referred to as UM), represented by Prof. Dr. Hariyono, M.Pd., Rector of UM; American Councils for International Education (hereinafter referred to as American Councils), represented by Dr. Brian Gibson, Vice President, Language Programs; and the University of Wisconsin-Madison, represented by Dr. Frances Vavrus, Dean and Vice Provost of the International Division, enter into the following Memorandum of Understanding:

1. OBJECTIVES

In order to promote cooperation on the SEAFLLI-Indonesian program among Universitas Negeri Malang, American Councils for International Education, and the University of Wisconsin-Madison, and desiring to uphold and expand scholarly ties, facilitate academic cooperation, and promote mutual understanding, the Parties commit to a framework for educational and scientific cooperation.

2. AREAS OF COOPERATION

With these goals in mind, the Parties will:

- Continue to support undergraduate and graduate students enrolled in the SEAFLLI-Indonesian program, as detailed in separate agreements;
- Sustain or increase activities surrounding current collaboration related to the SEAFLLI-Indonesian program;

Themes of joint activities and the conditions for utilizing the results achieved during specific visits, exchanges, and other forms of cooperation will be developed mutually for each specific case. Any commitment of resources, financial or otherwise, must be made in specific agreements to be entered into for this purpose at a subsequent date. The Parties agree to consult periodically concerning the status of these explorations and other relevant matters.

3. TERM OF THIS AGREEMENT

This Memorandum of Understanding will take effect on May 29, 2026, and will remain in effect until December 31, 2026, unless extended by mutual agreement.

All Parties reserve the right to terminate this Memorandum of Understanding at any time by giving written notice to the Administrative Representative of the other Parties at least 30 days prior to the effective date of termination.

This Memorandum of Understanding represents the entire agreement among the Parties on the matters set forth herein.

This Memorandum of Understanding may be executed by electronic means and in counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

By signing this Memorandum of Understanding, each Party represents that it has the authority to bind the respective Parties to all provisions hereof.
