sebagai Income Generating dan Pelatihan Keterampilan” activity in the Chemistry Study Program as stipulated in the following articles:

Article 1

AIMS AND OBJECTIVES

- (1) This Implementation Agreement serves as the basis for the execution of the collaboration as prepared and agreed upon by **THE PARTIES**, in accordance with the scope defined herein.
- (2) The objective of this Agreement is to support mutual activities, particularly the implementation of a joint community service, focusing on Smart Foodprep: Kids Meal Preparation dengan Teknik Pengawetan Quick Freezing Sebagai Peningkatan Skill Siswa Sanggar Bimbingan Klang Lama dan Kerjasama Penta-Helix UM dan Diaspora Indonesia.

Article 2

SCOPE OF ACTIVITIES

- (1) The scope of this cooperation includes the planning, organization, and execution of the joint community service by **THE FIRST PARTY** at the institution of **THE SECOND PARTY**.
- (2) **THE PARTIES** shall jointly monitor the implementation of the joint community service at least twice during the activity period.

Article 3

FINANCING

- (1) All costs incurred in the implementation of this Agreement shall be borne by each PARTY in accordance with their respective obligations, responsibilities, and budget capabilities, and shall not contradict the provisions of prevailing laws and regulations.
- (2) In addition to the financing referred to in paragraph (1), the implementation of this Agreement may be funded from other legitimate sources, provided that such funding does not contradict the provisions of prevailing laws and regulations and is agreed upon by THE PARTIES.
- (3) Further provisions regarding the financing as referred to in paragraph (1) shall be regulated in the work plan (action plan) as referred to in Article 3 paragraph (1).

CONCLUSION


- (1) Amendments to this Implementation Agreement may only be made with the mutual consent of THE PARTIES.
