UNIVERSITI PUTRA MALAYSIA, MALAYSIA

FOR INBOUND and OUTBOUND MOBILITY

This agreement is signed on, 1st September 2026, by the following parties:

1. Assoc. Prof. Dr. Arbin Janu Setyowati, M.Pd : Vice Dean of International Affairs Faculty of Education, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. Dr. Mohd Hazwan Mohd Puad, Head of Department of Science and Technical Education, Faculty of Educational Studies, Universiti Putra Malaysia, located at Serdang, Selangor, Malaysia, hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for inbound activities is developed and established between **THE PARTIES** under the following terms:

Article 1
PURPOSE AND
OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop inbound activities between **THE PARTIES**

Article
2
SCOPE

- (1) The scope of this Implementation of Agreement includes inbound activities between the faculty members of **THE PARTIES**.
- (2) **THE PARTIES** shall monitor the implementation of inbound activities at least twice in 1 (one) year.

Article 3
FUNDING

- (1) Funding for this inbound activities amounts to RM. 290 / IDR. 1.300.000 per student and shall be covered by **THE SECOND PARTY**
- (2) The **THE FIRST PARTY** will not be responsible to cover the costs of return flight and medical treatment or hospitalization for visiting scholars or students, and it is recommended that visitors should obtain overseas health insurance coverage from their home country.
- (3) Funding for accommodation (Hotel) of accompanying lecturer is shall be covered by **THE FIRST PARTY**

**Article 4
DURATION**

This Implementation of Agreement is effective since September 1st, 2026 and valid until September 1st, 2027

**Article 5
OTHER MATTERS**

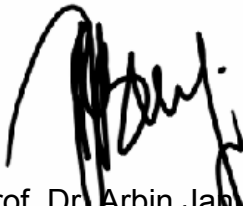
- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for inbound activities and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
