Today, **Wednesday, September 9**, the year **two thousand and twenty-six (9-09-2026)**, located at the **Faculty of Social Sciences State University of Malang**, the following signature:

1. **Indah Wahyu Puji Utami, Ph.D.:** Head of the History Department therefore legally represents and acts for and on behalf of the S1 History Education Study Program, Faculty of Social Sciences, State University of Malang, which is located at Jalan Semarang 5, Malang, hereinafter referred to as **the FIRST PARTY**.
2. **Dr. Fernando A. Santiago, Jr.:** Director of De La Salle University - the Southeast Asia Research Center and Hub (DLSU-SERACH), therefore, legally represents and acts for and on behalf of the Southeast Asia Research Center and Hub which is located in 2401 Taft Avenue, Manilla, 1004, the Philippines hereinafter referred to as **the SECOND PARTY**.

PARTY I and **PARTY II** hereinafter referred to collectively as **THE PARTIES**. The Parties hereby agree to jointly arrange an Implementation Agreement on the program Research and Publication Organized by **THE PARTIES** as regulated in the following articles.

Article 1 **AIMS AND OBJECTIVES**

- (1) The purpose of this Cooperation Implementation Draft is as a basis for the implementation of cooperation prepared by **THE PARTIES** in accordance with the scope of this Implementation of Agreement.
- (2) The purpose of this Implementation of Agreement is to support each other's activities in the framework of cooperation related to (1) the program of research and publication titled "Pluralistic Religious Societies and Cultural Crossroads in the Early Modern Sultanate of Tidore, Indonesia"

Article 2
SCOPE OF ACTIVITIES

- (1) The Scope of this agreement includes) the program of research and publication titled “Pluralistic Religious Societies and Cultural Crossroads in the Early Modern Sultanate of Tidore, Indonesia”, wherein Indah Wahyu Puji Utami, Ph.D. has been assigned as the Person in Charge (indahwahyu.p.u@um.ac.id).
- (2) The implementation of cooperation for this agreement is carried out by **THE PARTIES**.
- (3) **THE PARTIES** shall monitor the implementation of the program Nusantara Arts Showcase not less than 1 (one) time in one period of activity.
- (4) **THE PARTIES** are to carry out organization of the showcase as stated in the attachment.

Article 3
FINANCING

- (1) The cost of research and publication titled “Pluralistic Religious Societies and Cultural Crossroads in the Early Modern Sultanate of Tidore, Indonesia” is charged to each **PARTY**.

Article 4
DURATION

This Implementation Agreement of cooperation is valid from 9/09/2026 until 9/09/2027.

Article 5
CLOSING

- (1) Any amendment to this Implementation Agreement shall only be made with the mutual approval of **THE PARTIES**.
- (2) This Implementation Agreement is deemed to be terminated if one **PARTY** or **THE PARTIES** fail to fulfill the provisions in this Implementation Agreement.
- (3) Particulars that are not/yet to be determined in this Implementation Agreement shall be addressed further by **THE PARTIES** on the basis of mutual discussion and agreement which shall be set forth in an Addendum, which is an integral part of this Implementation Agreement.
- (4) This document of Implementation Agreement is made and signed by **THE PARTIES** in 2 (two) copies, all of which shall constitute the equal legal force.

Article 6
Force Majeure

- (1) In the event of force majeure, including natural disasters, fires, security disturbances and other matters that result in the **PARTIES** being unable to carry out the obligations as referred to in ARTICLE 3, the losses suffered by the **PARTIES** shall be borne by the **PARTIES** and **the PARTIES** shall be released from claims for the implementation of this Memorandum of Understanding including claims for losses arising from this force majeure.
- (2) The circumstances as referred to in paragraph (1) must have a direct causal relationship with the losses suffered by the **PARTIES** and be proven by a Certificate from an Authorized Official no later than 30 (thirty) working days from the occurrence of the event as referred to in paragraph (1).

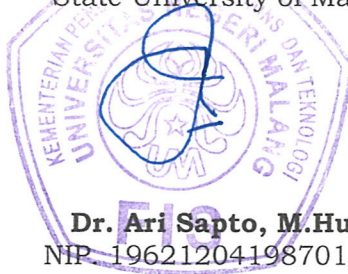
