**Article 1**  
**AIMS AND OBJECTIVES**

- (1) The purpose of this Cooperation Implementation Draft is as a basis for the implementation of cooperation prepared by the PARTIES in accordance with the scope of this Cooperation Implementation Regulation.
- (2) The purpose of this Cooperation Implementation Plan is to support each other's activities in the framework of cooperation related to the delivery of a Guest Lecture by **Prof. Dr. Hadi Suwono** on the topic of on Entrepreneurs STEM, aimed at students and faculty at NTNU.

**Article 2**  
**SCOPE OF ACTIVITIES**

- (2) This collaboration activity may also include discussion forums, knowledge-sharing sessions, and potential follow-up academic collaborations in the future.
