**DURATION**

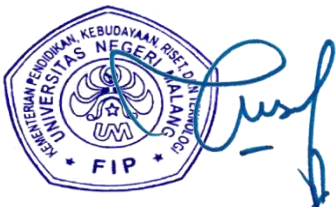
This implementation of agreement is effective on March 2025 until December 2025
