On this day, 19th of November, 2025, the undersigned parties:

1. **Prof. Dr. Sapto Adi, M.Kes:** Dean of Faculty of Sports Science, Universitas Negeri Malang (UM), having the address at Jalan Semarang 5 Malang, in this regard acts for and on behalf of Universitas Negeri Malang (UM), hereinafter referred to as the **PARTY ONE**.
2. **Dr. Jaffry Bin Zakaria:** Dean of Faculty of Sports Science and Coaching, Universiti Pendidikan Sultan Idris (UPSI) 35900 Tanjong Malim, Perak Darul Ridzuan hereinafter referred to as the **PARTY TWO**.

PARTY ONE and **PARTY TWO**, hereinafter referred to as the **PARTIES**, agree to sign this Memorandum of Agreement in the field of Improving the *Tridarma* of Higher Education through the Development of Education, Research, Community Service in accordance with the vision and mission of their respective Universities under the provisions as set out in the articles as follows:



**Article 1
GENERAL**

In this Agreement includes activities:

- (1) Research Collaboration (Cooperation between **PARTIES** and individuals in conducting joint research in certain agreed fields);
- (2) Community Service Collaboration (Collaboration which aims to apply science and technology in an effort to solve problems and improve the quality of life of the community);
- (3) Educational Collaboration (Collaboration aims to provide teaching experience in certain agreed areas)

**Article 2
SCOPE**

Within the limits of existing capabilities, the scope of this Memorandum of Agreement includes activities concerning:

- (1) Education, includes:
 - a. Internship
 - b. Guest lecture, Teaching Practitioner, Academic Discussion
 - c. Workshop and Seminar
 - d. Other activities mutually agreed upon the **PARTIES**.
- (2) Research, includes:
 - a. Research collaboration
 - b. Joint publication
 - e. Other activities mutually agreed upon the **PARTIES**.
- (3) Community Services



Article 3 PURPOSE

This Memorandum of Agreement is carried out with the aim of utilizing the capabilities of both parties to successfully carry out their respective tasks in order to achieve the Development of the *Tridharma* of Higher Education at Universitas Negeri Malang (UM) and Universiti Pendidikan Sultan Idris.

Article 4 RIGHTS AND OBLIGATIONS

- (1) **THE PARTIES** are obliged to make activities a success by optimizing the joint use of the resources owned by each PARTY, and can be held accountable according to their respective abilities.
- (2) **THE PARTIES** are obliged to assist each other in carrying out monitoring (supervision) and evaluation in accordance with their respective roles in cooperative activities.
- (3) The rights and obligations of the **PARTY ONE** are:
 - a. **PARTY ONE** has the right to receive operational support for activities with the written consent of THE PARTIES.
 - b. **PARTY ONE** obligation is to prepare/assign experts/lecturing staff needed to carry out this collaborative activity.
- (4) The rights and obligations of the **PARTY TWO** are:
 - a. **PARTY TWO** has the **right** to obtain human resources that do not have academic and non-academic problems from the **FIRST PARTY**.
 - b. **PARTY TWO** has the right to obtain expert staff/lecturing staff from the FIRST PARTY with the necessary qualifications to support activities.

- c. **PARTY TWO** has the right to determine and place students (if involved) according to their expertise in accordance with the names recommended by the **FIRST PARTY**.
- d. The obligation of **PARTY TWO** is to communicate about activity plans, distribute the tasks or roles of the **PARTIES** in activities, and participate in meetings or meetings or coordination if necessary.

THE **PARTIES** agree that for activities as referred to in article 2 paragraph (2), the rights and obligations governing the roles of the **PARTIES** will be discussed according to the agreement

**Article 5
DURATION**

This Memorandum of Agreement is valid for 3 year from the date of signature and may be extended upon the agreement of the **PARTIES**.

**Article 6
FUNDING**

The costs for this activity are borne by the **PARTIES** in accordance with the provisions of the **PARTIES'** agencies and will be stated in the contract/cooperation implementation plan as an inseparable part of this cooperation agreement.

**Article 7
DISPUTE RESOLUTION**

- (1) This Memorandum of Agreement is made based on the goodwill of both parties in order to improve the quality of the implementation of the *Tridarma* of Higher Education at Universitas Negeri Malang (UM) and Universiti Pendidikan Sultan Idris (UPSII). For this reason, any discrepancies that may occur will be resolved by deliberation and consensus.
- (2) In the event of a dispute that cannot be resolved by deliberation, the **PARTIES** agree to seek solution at the Malang City Court.

**Article 8
FORCE MAJEURE**

- (1) In the event of force majeure, including natural disasters, fires, security disturbances and other matters that result in the **PARTIES** being unable to carry out the obligations as referred to in ARTICLE 3, the losses suffered by the **PARTIES** shall be borne by the **PARTIES** and the **PARTIES** shall be released from claims for the implementation of this Memorandum of Agreement Including claims for losses arising from this force majeure.

- (2) The circumstances as referred to in paragraph (1) must have a direct causal relationship with the losses suffered by the **PARTIES** and be proven by a Certificate from an Authorized Official no later than 30 (thirty) working days from the occurrence of the event as referred to in paragraph (1).
