1. **Dr. Lokananta Teguh Hari Wiguno, M.Kes.:** Head of Physical Education, Health, and Recreation Department, acting on behalf of Bachelor of Physical Education, Health, and Recreation Department Study Program, Faculty of Sports Science, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. **Profesor Madya Dr. Ali bin Md Nadzalan:** a visiting faculty member from Malaysia under the management of Department of Sports Science and Coaching, Sultan Idris Education University (UPSI), located in 35900 Tanjong Malim, Perak, Malaysia, Malaysia. hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and THE SECOND PARTY hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Guest Lecturer is developed and established between **THE PARTIES** under the following terms:

Article 1

PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop staff/lecturers between **THE PARTIES**.

Article 2

SCOPE

- (1) The scope of this Implementation of Agreement includes a Guest Lecturer entitled "*Winning by Design: The Science Behind Elite Athletic Performance*" within **THE PARTIES**.
- (2) **THE PARTIES** shall monitor the implementation of Guest Lecturer.
- (3) The Guest Lecturer involves several staff/lecturers.

- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for teaching collaborations and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.

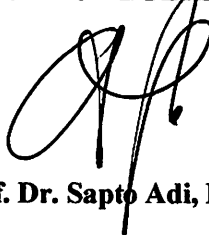
