1. **Dr. Lokananta Teguh Hari Wiguno, M.Kes.:** Head of the Physical Education Department, acting on behalf of Bachelor of Public Health Study Program, Department of Public Health, Faculty of Sports Science, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. **Reymart J. Canja, MSPE, LPT:** a visiting faculty member from Philippines under the management of Department of Physical Education, Mindanao State University, located on General Santos City, 9500 South Cotabato, Philippines, hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and THE SECOND PARTY hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Guest Lecturer is developed and established between **THE PARTIES** under the following terms:

**Article 1
PURPOSE AND OBJECTIVE**

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop staff/lecturers between **THE PARTIES**.

**Article 2
SCOPE**

- (1) The scope of this Implementation of Agreement includes Guest Lecturer entitled "*Rolling into Innovation: Assessing the Adaptability, Acceptability, and Playability of Bowlcraft, a Pin-based game for Physical Education Classes*" within the **THE PARTIES**.


