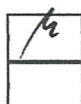

2. **Rui Yao: Editor of Atlantis Press, Springer Nature** therefore legally represents and acts for and on behalf of Atlantis Press, Springer Nature, which is located in Room 1102, Building 6, Greenland New Metropolis, 80 Jinshui East Road, Zhengdong New District, Zhengzhou, China, hereinafter referred to as the **SECOND PARTY**.

THE FIRST PARTY AND THE SECOND PARTY ARE HEREINAFTER REFERRED TO AS THE PARTIES. It is hereby agreed to jointly make a Cooperation Implementation Plan Regarding **Publication for The 3rd International Conference on Citizenship Education And Democratic Issues (ICCEDI)** which is carried out by **the PARTIES** as stipulated in the following article.

Article 1 **AIMS AND OBJECTIVE**

- (1) The purpose of this Cooperation Implementation Draft is as a basis for the implementation of cooperation prepared by **the PARTIES** in accordance with the scope of this Cooperation Implementation Regulation.



- (2) The purpose of this Cooperation Implementation Plan is to support each other's activities in the framework of cooperation related to the **Publication for The 3rd International Conference on Citizenship Education And Democratic Issues (ICCEDI)**.

Article 2

SCOPE OF ACTIVITIES

- (1) The scope of this collaboration activity includes the **Publication for the 3rd International Conference on Citizenship Education and Democratic Issues (ICCEDI)**.
- (2) **PARTIES** monitor the implementation of the **Publication for the 3rd International Conference on Citizenship Education and Democratic Issues (ICCEDI)** at least 2 (two) times in 1 (one) activity period.

Article 3

FINANCING

The cost of the **Publication for the 3rd International Conference on Citizenship Education and Democratic Issues (ICCEDI)** is charged to the **FIRST PARTY**.

Article 4

PERIOD

The period of the Cooperation Implementation Design is for 1 year, from July 17, 2026 to July 17, 2027

Article 5

CONCLUSION

- (3) Changes to the draft of the Cooperation Implementation Plan can be made with the approval **of the PARTIES**.
- (4) This Cooperation Implementation Plan may be considered void if one of the **PARTY** or **PARTIES** does not meet the provisions in the Cooperation Implementation Plan.
- (5) Matters that are not or have not been regulated in the draft of this Cooperation Implementation Draft will be regulated later by **the PARTIES** on the basis of deliberation or consensus which will then be outlined in the Addendum and are an integral part of this Cooperation Implementation Plan.
- (6) The Draft Implementation of Cooperation is made and signed by **the PARTIES** in 2 (two) copies that have the same legal force.
