INBOUND ACTIVITIES

This agreement is signed on, Friday, 30th April 2025, by the following parties:

1. Assoc. Prof. Dr. Ahmad Yusuf Sobri, S.Sos., M.Pd : Dean of Faculty of Education, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. Assoc. Prof. Dr. Astri Yulia: Director of International Office, Universiti Selangor located Jalan Timur Tambahan 45600 Bestari Jaya Selangor Darul Ehsan Malaysia, hereby referred as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for inbound activities is developed and established between **THE PARTIES** under the following terms:

Article 1
PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop inbound activities between **THE PARTIES**

Article 2
SCOPE

- (1) The scope of this Implementation of Agreement includes inbound activities between the faculty members of **THE PARTIES**.
- (2) **THE PARTIES** shall monitor the implementation of inbound activities at least twice in 1 (one) year.

Article 3
FUNDING

- (1) Funding for this inbound activities amounts to USD \$100 per student per week and shall be covered by **students of THE SECOND PARTY**.
- (2) The **THE FIRST PARTY** will not be responsible to cover the costs of return flight and medical treatment or hospitalization for visiting scholars or students, and it is recommended that visitors should obtain overseas health insurance coverage from their home country.

**Article 4
DURATION**

This Implementation of Agreement is effective since June 30th, 2025 and valid until December 30th, 2025

**Article 5
OTHER MATTERS**

- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for inbound activities and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
