This agreement is signed on Thursday, 5th September, 2024, by the following parties:

2. **Fernando A. Santiago, Jr., Ph.D.**: Director of the Southeast Asia Research Center and Hub (SEARCH), De La Salle University, located in 2401 Taft Avenue, Manila 0922, Philippines, hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** hereinafter shall collectively be referred to as **THE PARTIES**. This implementation of agreement for the International Co-Teaching Programs is developed and established between **THE PARTIES** under the following terms.

Article 1 **AIMS AND OBJECTIVES**

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to conduct International Co-Teaching Programs between **THE PARTIES**.

Article 2 **SCOPE**

- (1) The scope of this implementation of the Agreement includes International Co-Teaching Programs on the topic "Introduction to the World History (especially Southeast Asian Nationalism)" on 5 September 2024 by Dr. Jose Victor Torres.

- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for the International Co-Teaching Programs and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
