Article 1
PURPOSE

This agreement aims to establish cooperation between the Department of German Literature, Mandarin Language Education Program at Universitas Negeri Malang (hereinafter referred to as "Party 1") and Guangxi Normal University (hereinafter referred to as "Party 2"), in conducting a 3+1 student exchange program collaboration between the two universities.

Article 2
REGULATIONS AND AREA OF COOPERATION

1. **The second party** agrees to accept 10 or more students from the **first party** to study Mandarin with the second party for 1 year (2 semesters).
2. **The first party** agrees to accept 10 or more students from the **second party** to study Indonesian with the first party for 1 year (2 semesters).
3. **Both parties** must provide each other with relevant information regarding student admission 5 months before the students depart, and prepare student admission documents.
4. **Both parties** carry out the learning process in accordance with the curriculum and requirements that have been previously agreed upon.
5. **Both parties** recognize the students' academic credits based on this cooperation agreement. Both parties must arrange safe on-campus accommodation facilities.

Article 3
FINANCIAL ARRANGEMENTS

Students participating in this program must pay tuition fees to their respective universities according to the previously determined price. Round trip travel costs, food and boarding costs, book costs, visa processing costs, insurance premiums and other personal costs are borne by the students concerned.

Article 4
DISPUTE RESOLUTION

Any disputes arising from the implementation of this agreement will be resolved amicably through mutual deliberation.

If a resolution cannot be reached through deliberation, the parties agree to resolve the dispute through mediation.

Article 5 **MISCELLANEOUS**

This agreement is written in Chinese and English, with a total of 4 copies. The first party and the second party each hold one copy in Mandarin and one copy in English.

This agreement comes into force on the date of signing by both parties and will be valid for 5 years.
