
2. Dr. MD Arifur Rahman

THE FIRST PARTY and THE SEOND PARTY hereinafter shall collectively be referred to as THE PARTIES. This Memorandum of Agreement for Research and Community Service Collaboration is development of Academic, Research, Community Service in accordance with the vision and mission of the Universitas Negeri Malang under the following terms:

Article 1 OBJECTIVE

The objective of this Memorandum of Agreement is to utilize the capabilities of both parties to succeed each of its capabilities to achieve the development of the Tridharma Perguruan Tinggi at the Faculty of Economics and Business, Universitas Negeri Malang (UM) and Logic Art Automation Co., Ltd.

Article 2 SCOPE

The areas of collaboration on academic, research, and community service activities covered under this Memorandum of Agreement are as follows:

- (1) Academic such as transdisciplinary lectures, internship, workshop, conference, and symposium;
- (2) Research and Development Knowledge are to conduct research and writing of scientific papers together; and
- (3) Community Service.

Article 3 IMPLEMENTATION AND ACTIVITY

- (1) The implementation of this activity is technically regulated by each party involved in this Memorandum of Agreement, both Faculty of Economics and Business Universitas Negeri Malang and Logic Art Automation Co., Ltd.
- (2) This agreement is held for Bachelor of Accounting, Bachelor of Accounting Education, and Master of Accounting representing Faculty of Economics and Business, Universitas Negeri Malang.
- (3) The rule of this Memorandum of Agreement is regulated in a separated Implementation of Agreement, which is inseparable from this Memorandum of Agreement.

Article 4 FUNDING

Everything that includes financing issues related to the implementation of this Memorandum of Agreement and the technical rules for its implementation are regulated in a separate Implementation of Agreement, which cannot be separated from this Memorandum of Agreement.

Article 5 DURATION

- (1) This Memorandum of Agreement shall be effective from the date of this Agreement and continue for the duration of three years from that date;
- (2) This Memorandum of Agreement may be terminated even though the time in paragraph 1 of this article has not yet expired with the agreement of **THE PARTIES**.

Article 6 SETTLEMENT OF DIFFERENCES

(1) This Memorandum of Agreement was made with the good intention of THE PARTIES to develop the quality of implementation of higher education's Tridarma in the Faculty of Economics and Business, Universitas Negeri Malang and Logic Art Automation Co., Ltd. For this reason, any differences that occur can be solved with negotiations.

Paraf Pihak Kesatu Paraf Pihak Kedua (2) If the differences cannot be solved with deliberate and consensus, it will be solved in Malang City District Court.

Article 7 **OTHER MATTERS**

- (1) Amendments to this Memorandum of Agreement can only be made with the mutual written consent of both parties.
- (2) Other matters outside this Memorandum of Agreement can be written in an Addendum attached as an integral part of this Memorandum of Agreement document.

Article 8 CONCLUDE

This Memorandum of Agreement was made and signed in two copies. Each Memorandum of Agreement is sufficiently stamped and has the same legality, one copy for the Faculty of Economics and Business Universitas Negeri Malang and the other for Logic Art Automation Co., Ltd.
