Regarding to Memorandum of Understanding that was signed on, 2<sup>nd</sup> October 2023, the following parties:

1. Dr. Hadi Sumarsono , ST, M.Si : Dean Faculty of Economic And Business, acting on behalf of Faculty of Economic and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereinafter referred to as **THE FIRST PARTY**
2. Prof. Madya Dr. Ahmed Razman bin Abdul Latiff : Director of Coursework Programs, Putra Business School (PBS), located on Putra Business School, Level 3, Office Building of the Deputy Vice Chancellor (Research & Innovation) 43400, UPM, 43400 Seri Kembangan, Selangor, Malaysia, hereinafter referred to as **THE SECOND PARTY** .

**THE FIRST PARTY** and **THE SECOND PARTY** hereinafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement is developed and established between **THE PARTIES** under the following terms:

### Article 1

#### PURPOSE AND OBJECTIVES

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Agreement are research activity programs between **THE PARTIES**

## Article 2

### SCOPE

The scope of this Implementation of Agreement includes Research activity programs by the faculty members of **THE PARTIES**.

## Article 3

### RIGHTS AND OBLIGATIONS

#### (1) Rights and Obligations **THE FIRST PARTY**:

- a. **THE FIRST PARTY** has the right to access facilities for research activity conducted in the Putra Business School (PBS) in accordance with applicable regulations and the terms of this agreement.
- b. **THE FIRST PARTY** is obligated to inform **THE SECOND PARTY** of research activity, no later than 1 (one) month before the activity implementation.

#### (2) Rights And **SECOND PARTY** Obligations :

- a. **THE SECOND PARTY** has the right to access facilities from **FIRST PARTY** for research activity in accordance with applicable regulations and the terms of this agreement.
- b. **THE SECOND PARTY** is obligated inform related activities with research to **FIRST PARTY**, no later than 1 (one) month before the activity implementation.

## Article 4

### DURATION OF THE AGREEMENT



- (1) This agreement applied for 5 (five) years period, counted since date signed by **the FIRST PARTY** and **THE SECOND PARTY**
- (2) This agreement can be extended or renewed by the **FIRST PARTY** and the **SECOND PARTY** agreement, at least 1 (one) month before the agreement's expiration date.

## Article 5

### FORCE MAJEURE

- (1) If force majeure happen, **THE SECOND PARTY** is released from the obligation to carry out this agreement in whole or in part.
- (2) Force majeure refers to situations beyond the control of **THE SECOND PARTY**, such as natural disasters, riots, wars, fires, government actions affecting the monetary field, and other circumstances beyond the control of both parties.

- (2) This Implementation of Agreement shall be terminated if one of **THE PARTIES** violates the mutually agreed terms and conditions.
- (3) Other matters not covered by this Implementation of Agreement shall be discussed by **THE PARTIES** and may be documented in an addendum, which will be an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for guest lecture programs and is established and signed by **THE PARTIES** in duplicate; all copies are equally authentic.
