AND EXERCISE AND SPORT SCIENCE PROGRAMME, SCHOOL OF HEALTH SCIENCE, UNIVERSITI SAINS MALAYSIA, MALAYSIA

FOR INTERNATIONAL SEMINAR COLLABORATION

This Implementation Agreement (IA) on International Seminar Collaboration is entered into force on May 2nd, 2023 between **Department of Public Health**, **Faculty of Sports Science**, **Universitas Negeri Malang (FSS UM Malang)**, hereinafter referred to as Party I, and **Exercise and Sport Science Programme**, **School of Health Science**, **Universiti Sains Malaysia**, **Malaysia (SHS USM)** hereinafter referred to as Party II. Both FSS UM Malang and SHS USM shall collectively be referred to as the Parties.

In order to promote their mutual interests, the Parties are seeking to establish a collaboration on the organization as an Invited Speaker for **The 5th International Scientific Meeting on Public Health and Sports (ISMoPHS)**. This agreement is an implementation of an activity valid from May 1st, 2023 until December 29th 2025. This agreement may be extended for a further period as may be agreed in writing by the Parties.
