Explaining that Party 1 and Party 2 had agreed to carry out the implementation of the cooperation that had been agreed upon, with the following arrangements:


1. Party 2 sends lecturers to do guest lecture and technical assistance in Party 1.

8. If a dispute arises in the implementation of the activity, the settlement will be carried out by deliberation for consensus of both parties.


Thus, the Implementation of Agreement (IA) was drawn up and signed on the day, date, month, and year mentioned above for Party 1 and Party 2.
