
This Implementation Agreement is entered into force on the 23<sup>nd</sup> of April 2024 by and between:

- Dr. Azizatuz Zahro, S.Pd, M.Pd; Head of Indonesian Language and Literature Education Study Program whom therefore legally represents and acts for and on behalf Indonesian Language and Literature Education Study Program, Faculty of Letters, Universitas Negeri Malang, located at the address Jalan Semarang 5, Malang, hereinafter referred to as Party I.
- Prof. Madya Dr. Mohamad Saleeh Rahamad, Head of Media and Communication Studies Study Program, Faculty of Art and Social Science, Universiti Malaya, located at the address Universiti Malaya, Lingkungan Budi, 50603 Kuala Lumpur, Federal Territory of Kuala Lumpur, Malaysia, hereinafter referred to as Party II.

PARTY I and PARTY II hereinafter referred to collectively as THE PARTIES. The Parties hereby agree to jointly arrange an Implementation Agreement on the program GUEST LECTURE

Organized by THE PARTIES as regulated in the following articles.

#### Article 1 PURPOSE AND OBJECTIVES





- (1) The purpose of this Implementation Agreement is to serve as the basis for the Implementation Agreement arranged by **THE PARTIES** in accordance with the scope of this Implementation Agreement Regulation.
- (2) The objective of this Implementation Agreement is to support the activities of **THE PARTIES** in relation to cooperations in regard to the program **GUEST LECTURE**

#### Article 2 SCOPE OF ACTIVITIES

- (1) The Scope of this agreement includes the program GUEST LECTURE, wherein <a href="mailto:amalia.nurma.fs@um.ac.id">amalia.nurma.fs@um.ac.id</a> has been assigned as the Person in Charge (email of the responsible person).
- (2) **THE PARTIES** shall monitor the implementation of the program not less than 2 (two) times in one period of activity.
- (3) THE PARTIES are to carry out GUEST LECTURE program as stated in the attachment bellow

#### Article 3 FUNDING

The funding for accommodation will be provided by party I. However, party II will do the utmost to provide appropriate on-campus accommodation for the lecturers.

## Article 4 DURATION

This Implementation Agreement of cooperation is valid from the 23<sup>nd</sup> of April 2024

### Article 5 CLOSING

- (1) Any amendment to this Implementation Agreement shall only be made with the mutual approval of **THE PARTIES**.
- (2) This Implementation Agreement is deemed to be terminated if one **PARTY** or **THE PARTIES** fail to fulfill the provisions in this Implementation Agreement.
- (3) Particulars that are not / yet to be determined in this Implementation Agreement shall be addressed further by **THE PARTIES** on the basis of mutual discussion and agreement which shall be set forth in an Addendum, which is an integral part of this Implementation Agreement.



(4) This document of Implementation Agreement is made and signed by **THE PARTIES** in 2 (two) copies, all of which shall constitute the equal legal force.
