This Implementation Agreement is entered into force on 15 November 2023 by and between:

1. **Dr. Slamet Raharjo, M.Or** : Head of Sports Science Department, whom therefore legally represents and acts for and on behalf of the Sports Science Department, Faculty of Sports Science, Universitas Negeri Malang, whose address is at Jalan Semarang 5, Malang, hereinafter referred to as Party I.
2. **Dr. Rudiah Binti Md Hanafiah** : Head of Programme Maritime Management, whom therefore legally represents and acts for and on behalf of Faculty of Maritime Studies, Universiti Malaysia Terengganu, whose address is at Kuala Terengganu, Terengganu, Malaysia, hereinafter referred to as Party II.

**PARTY I** and **PARTY II** hereinafter referred to collectively as **THE PARTIES**. The Parties hereby agree to jointly arrange an Implementation Agreement on the Guest Lecture program Organized by **THE PARTIES** as regulated in the following articles.

### **Article 1 PURPOSE AND OBJECTIVES**

- (1) The purpose of this Implementation Agreement is to serve as the basis for the Implementation Agreement arranged by **THE PARTIES** in accordance with the scope of this Implementation Agreement Regulation.



- (2) The objective of this Implementation Agreement is to support the activities of **THE PARTIES** in relation to corporations in regard to the program of Guest Lecture

## **Article 2 SCOPE OF ACTIVITIES**

- (1) The Scope of this agreement includes the program of Guest Lecture, wherein Nohan Arum Romadlona, M.K.M has been assigned as the Person in Charge (arum.romadlona.fik@um.ac.id)
- (2) The implementation of cooperation for this agreement is carried out by Department of Sports Science
- (3) **THE PARTIES** are to carry out Guest Lecture as stated in the appendix.

## **Article 3 FUNDING**

No monetary sharing is enforced to this agreement. Should there be changes of funding agreement, a separate and specific agreement shall be prepared and meet the approval of the parties.

## **Article 4 DURATION**


This Implementation Agreement of cooperation is valid from 15 November 2023 to 25 December 2025.

- (3) Particulars that are not / yet to be determined in this Implementation Agreement shall be addressed further by **THE PARTIES** on the basis of mutual discussion and agreement which shall be set forth in an Addendum, which is an integral part of this Implementation Agreement.

(4) This document of Implementation Agreement is made and signed by **THE PARTIES** in 2 (two) copies, all of which shall constitute the equal legal force.


