

MEMORANDUM OF AGREEMENT

BETWEEN FACULTY OF SPORTS SCIENCES UNIVERSITAS NEGERI MALANG AND

INDONESIA EMBASSY OF REPUBLIC OF INDONESIA IN SINGAPORE

ON COMMUNITY DEVELOPMENT

This Implementation Agreement is entered into force on 28th of October 2003 by and between:

- 1. Kurniati Rahayuni, S.Psi., M.Psi., PhD: Head of Sports Coaching Education Department whom therefore legally represents and acts for and on behalf of the Study Program of Sports Coaching Education, Faculty of Sports Science, Universitas Negeri Malang, whose address is at Jalan Semarang 5, Malang, hereinafter referred to as Party I.
- 2. IGAK Satrya Wibawa, S.Sos., MCA., Ph.D: Education and Cultural Attaché of The Embassy of Republic of Indonesia in Singapore, whose address is at 7 Chatsworth Rd., Singapore 249761, hereinafter referred to as Party II.

PARTY I and **PARTY II** hereinafter referred to collectively as **THE PARTIES.** The Parties hereby agree to jointly arrange an Implementation Agreement on the program Socialization and education of pencak silat as an artistic performing arts in Indonesian and Singapore society Organized by **THE PARTIES** as regulated in the following articles.

Article 1 PURPOSE AND OBJECTIVES

- 1. The purpose of this Implementation Agreement is to serve as the basis for the Implementation Agreement arranged by **THE PARTIES** in accordance with the scope of this Implementation Agreement Regulation.
- 2. The objective of this Implementation Agreement is to support the activities of **THE PARTIES** in relation to cooperation in regard to the program titled "Artistic Pencak Silat Performance" as a Community Development.

Article 2 SCOPE OF ACTIVITIES

1. The Scope of this agreement includes the program titled "Artistic Pencak Silat Performance" wherein Kurniati Rahayuni S.Psi., M.Psi., PhD (kurniati.rahayuni.fik@um.ac.id) has/have been assigned as the Person in Charge.

2. The implementation of cooperation for this agreement is carried out by

FIRST PARTY facilitated by the SECOND PARTY.

4. **THE PARTIES** shall monitor the implementation of the program titled "Artistic Pencak Silat Performance" not less than 2 (two) times in one period of activity.

5. THE PARTIES are to carry out Community Development program titled

"Artistic Pencak Silat Performance" as stated in the appendix.

Article 3 FUNDING

This activity is funded by internal research grants of Universitas Negeri Malang and no monetary sharing is enforced in this agreement. The amount of funding is Rp. 25,000,000,- and is charged to **PARTY I**, which originates from The Non-Tax Revenue Internal UM funding. However, The Parties will not to any other relevant collaborative research grant application within the two Parties. Should there be changes of funding arrangements, a separate and specific agreement shall be prepared and meet the approval of THE PARTIES. This grant covers all research activities in Indonesia and publication fee.

Article 4 DURATION

This Implementation Agreement of cooperation is valid from 28th of October 2023 until 18th of October 2025 or until the completion of the Project, whichever is earlier. This agreement may be extended in writing by both Parties.

Article 5 CLOSING

- 1. Any amendment to this Implementation Agreement shall only be made with the mutual approval of **THE PARTIES**.
- 2. This Implementation Agreement is deemed to be terminated if one PARTY or THE PARTIES fail to fulfil the provisions in this Implementation Agreement.
- 3. Particulars that are not / yet to be determined in this Implementation Agreement shall be addressed further by **THE PARTIES** on the basis of mutual discussion and agreement which shall be set forth in an Addendum, which is an integral part of this Implementation Agreement.
