Academic, Administrative and Research Collaborations

This Implementation Arrangement (IA) on the organization of a visiting lecturer is entered into force on Wednesday, 8th November 2023, by and between Universitas Negeri Malang (UM), hereinafter referred to as Party I, and Pädagogische Hochschule Schwäbisch Gmünd, hereinafter referred to as Party II. Both UM and Pädagogische Hochschule Schwäbisch Gmünd collectively be reffered to as the Parties.

With reference to MoU between both parties dated 8th of February 2023, and in order to promote their mutual interest, the Parties are seeking to establish an academic, administrative, and research collaborations upon the terms as stated therein.

The technical details of the program from both parties are as written in the articles below.
