This Implementation Agreement is entered into force on 28 May 2024 by and between:

1. Dr. Nur Eva, S.Psi, M.Psi: Head of Unit/Head of Division/Director/Head of Department/Coordinator of Study Program Psychology, whom therefore legally represents and acts for and on behalf of the Study Program Psychology, Faculty of Psychology, Universitas Negeri Malang, whose address is at Jalan Semarang 5, Malang, hereinafter referred to as Party I.
2. Dr. Hasan Said Tortop: Director and Editor, Young Wise Publishing Ltd, whose address is at 63 – 66 Hatton Garden, Fifth Floor, Suite 23, London, EC1N 8LE London, UK, hereinafter referred to as Party II.

PARTY I and **PARTY II** hereinafter referred to collectively as **THE PARTIES**. The Parties hereby agree to jointly arrange an Implementation Agreement on the program Co-Teaching Program Organized by **THE PARTIES** as regulated in the following articles. The activity is in accordance with the provisions of Memorandum of Understanding signed by **THE PARTIES** on date/month/year.

Article 1

PURPOSE AND OBJECTIVES

- (1) The purpose of this Implementation Agreement is to serve as the basis for the Implementation Agreement arranged by **THE PARTIES** in accordance with the scope of this Implementation Agreement Regulation.
- (2) The objective of this Implementation Agreement is to support the activities of **THE PARTIES** in relation to cooperation with regard to the program Co-Teaching Program

Article 2
SCOPE OF ACTIVITIES

- (1) The Scope of this agreement includes the Co-Teaching Program, wherein Dr. Nur Eva, S.Psi, M.Psi. has been assigned as the Person in Charge (nur.eva.fppsi@um.ac.id).
- (2) The implementation of cooperation for this agreement is carried out by Young Wise Publishing Ltd
- (3) **THE PARTIES** shall monitor the implementation of the program Co-Teaching Program not less than 2 (two) times in one period of activity.
- (4) **THE PARTIES** are to carry out Co-Teaching Program as stated in the attachment.

Article 3
FUNDING

The amount of funding for this activity is Co-Teaching Program and is charged to each **PARTY**, which originate from Universitas Negeri Malang (WCU Equity Program) in the amount of IDR 12,780,300 Rupiah. The two parties shall agree on a specific budget planning. Any changes to the budget during the course of activity implementation should be mutually agreed by **THE PARTIES**.

Article 4
DURATION

This Implementation Agreement of cooperation is valid from 28 February 2024 until 28 June 2025

Article 5
CLOSING

- (1) Any amendment to this Implementation Agreement shall only be made with the mutual approval of **THE PARTIES**.
- (2) This Implementation Agreement is deemed to be terminated if one **PARTY** or **THE PARTIES** fail to fulfill the provisions in this Implementation Agreement.
- (3) Particulars that are not / yet to be determined in this Implementation Agreement shall be addressed further by **THE PARTIES** on the basis of mutual discussion and agreement which shall be set forth in an Addendum, which is an integral part of this Implementation Agreement.

(4) This document of Implementation Agreement is made and signed by **THE PARTIES** in 2 (two) copies, all of which shall constitute the equal legal force.

**Article 6
Force Majeure**

- (1) In the event of force majeure, including natural disasters, fires, security disturbances and other matters that result in the **PARTIES** being unable to carry out the obligations as referred to in ARTICLE 3, the losses suffered by the **PARTIES** shall be borne by the **PARTIES** and **the PARTIES** shall be released from claims for the implementation of this Memorandum of Understanding including claims for losses arising from this force majeure.
- (2) The circumstances as referred to in paragraph (1) must have a direct causal relationship with the losses suffered by the **PARTIES** and be proven by a Certificate from an Authorized Official no later than 30 (thirty) working days from the occurrence of the event as referred to in paragraph (1).


