This agreement is signed on, Tuesday, 14th March 2023, by the following parties:

1. Dr. H. Ludi Wishnu Wardana, M.M.: Head of the Master of Business and Management Education Study Program; acting on behalf of Master of Business and Management Education Study Program, Faculty of Economics and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. Prof Saliya De Silva: Professor of Faculty of Economics, Saga University, located on Japan, 〒840-0027 Saga, Honjomachi, 1 hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Research Collaboration and Workshop Programs is developed and established between **THE PARTIES** under the following terms:

Article 1 **PURPOSE AND OBJECTIVE**

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop research collaboration and workshop programs between **THE PARTIES**.

Article 2 **SCOPE**

- (1) The scope of this Implementation of Agreement includes research collaboration and workshop programs between the faculty members and students of **THE PARTIES**.
- (2) **THE PARTIES** shall monitor the implementation of research collaboration and workshop programs at least twice in 1 (one) year.

Funding for this seminar and workshop programs covered by first party.


**Article 4

- (4) This Implementation of Agreement is developed for research collaboration and workshop programs and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
