**THE FIRST PARTY** and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Teaching collaboration, Research collaboration, Community service collaboration, Joint publication, and Joint journal management is developed and established between **THE PARTIES** under the following terms:

### Article 1

#### PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope on this agreement mentioned in Article 2.

## **Article 2 SCOPE**

- (1) The scope of this Implementation of Agreement includes the program Teaching collaboration, Research collaboration, Community service collaboration, Joint publication, and Joint journal management.
- (2) This Implementation of Agreement activity encompasses the Economics Education Study Program with the responsible party being Ro'ufah Inayati, S.Pd., M.Pd. Head of Economics Education Study Program.
- (3) In the implementation of this Implementation of Agreement, it is carried out by students and lecturers.
- (4) **BOTH PARTIES** conduct monitoring of program Implementation shall be effective from the date of this Agreement and continue for the duration of two (2) years from that date.
- (5) **BOTH PARTIES** carry out Teaching collaboration, Research collaboration, Community service collaboration, Joint publication, and Joint journal management as stated in the attachment.

## **Article 3 FUNDING**

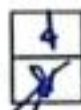
Funding for the Teaching collaboration, Research collaboration, Community service collaboration, Joint publication, and Joint journal management shall be covered by each **PARTY**.

- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
