This agreement is signed on Monday, 28th August, 2023, by the following parties:

1. **Lohana Juariyah, S.E., M.Si:** Head of the Management Study Program; acting on behalf of Management Study Program/Department, Faculty of Economics and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. **Dr. Zamzami Zainuddin:** a visiting faculty member from Malaysia under the management of Universiti Malaya, located on on 50603 Kuala Lumpur, Malaysia hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Visiting Lecturer is developed and established between **THE PARTIES** under the following terms:

Article 1

PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop staff/lecturers exchange between **THE PARTIES**.

Article 2
SCOPE

As a visiting lecturer, Party II is required to perform the following duties and undertake the following responsibilities in a professional manner.

- (1) Teaching at the Management Study Program, Management Department, Faculty of Economics and Business, Universitas Negeri Malang, with a workload of 9 credits.
- (2) Providing workshops for lecturers at the Management Study Program, Management Department, Faculty of Economics and Business, Universitas Negeri Malang.
- (3) Providing seminars that involve both lecturers and students of the Management Study Program, Management Department, Faculty of Economics and Business, Universitas Negeri Malang.
- (4) Providing advice on studying in Malaysia or another country.
- (5) Other duties may arise from time to time assigned by the Management Study Program, Management Department, Faculty of Economics and Business, Universitas Negeri Malang.

Article 3
FUNDING



Funding for the implementation of visiting lecturer mentioned above will be discussed further by **THE PARTIES**. Once agreed, the funding document will be attached as an addendum to this Letter.

Article 4
DURATION

This Implementation of Agreement is effective since 28th August 2023 and valid until 28th August 2028.


Article 5


(4) This Implementation of Agreement is developed for staff/lecturers exchange and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
