This agreement is signed on Monday, 28<sup>th</sup> August, 2023, by the following parties:

1. **Dr. Madziatul Churiyah, S.Pd, M.M.:** Head of the Office Administration Study Program, Management Department; acting on behalf of Office Administration Study Program/Department, Faculty of Economics and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. **Dr. Zamzami Zainuddin:** a visiting faculty member from Malaysia under the management of Universiti Malaya, located on 50603 Kuala Lumpur, Malaysia hereby referred to as **THE SECOND PARTY**.

**THE FIRST PARTY** and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Service Community Collaboration is developed and established between **THE PARTIES** under the following terms:

### Article 1

#### PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop Service Community collaboration between **THE PARTIES**.

### Article 2

#### SCOPE

- (1) The scope of this Implementation of Agreement includes Service Community collaboration between the faculty members and students of **THE PARTIES**.

- (2) **THE PARTIES** shall monitor the implementation of Service Community collaboration at least twice in 1 (one) year.
- (3) The Service Community collaboration between **THE PARTIES** involves several faculty members/lecturers and students.

**Article 3  
FUNDING**

Funding for the implementation of Service Community collaborations mentioned above will be discussed further by **THE PARTIES**. Once agreed, the funding document will be attached as an addendum to this Letter.

**Article 4  
DURATION**

This Implementation of Agreement is effective since 28<sup>th</sup> August 2023 and valid until 28<sup>th</sup> August 2028.

**Article 5  
OTHER MATTERS**

- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for Service Community collaboration and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.

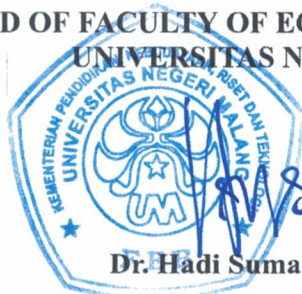
