1. **Lohana Juariyah, S.E., M.Si:** Head of the Bachelor of Management Study Program, Management Department; acting on behalf of Bachelor of Management Study Program, Department of Management, Faculty of Economics and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. **Assoc. Prof. Dr. Norliza Abdullah:** a visiting faculty member from Malaysia under the management of Faculty of Economics and Management, Universiti Kebangsaan Malaysia, located on 43600 UKM Bangi, Selangor Darul Ehsan, Malaysia, hereby referred to as **THE SECOND PARTY**.

**THE FIRST PARTY** and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Teaching Collaboration is developed and established between **THE PARTIES** under the following terms:

### **Article 1** **PURPOSE AND OBJECTIVE**

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop staff/lecturers between **THE PARTIES**.

### **Article 2** **SCOPE**

- (1) The scope of this Implementation of Agreement includes Teaching Collaboration within the **THE PARTIES**.

**Article 4  
DURATION**

OTHER MATTERS**

- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for teaching collaborations and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
