Today, Thursday 5 October 2023, the undersigned:

1. Dr. Dudy Syafruddin, S.S., M.A. : Head of Mandarin Language Education Study Program therefore legally represents and acts for and on behalf of the Mandarin Language Education Study Program, Faculty of Letters, State University of Malang, which is located at Jalan Semarang 5, Malang, hereinafter referred to as **THE FIRST PARTY**.
2. Ms QIN Ziyan: CEO of Go Study Global Education is therefore authorized to represent and act for and on behalf of the Go Study Global Education, which is located on 1105, Building 4#, Nanning Xin Xi Gang, Luban Road 95#, Nanning, Guangxi Zhuang Autonomous Region, P.R.C., hereinafter referred to as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** are hereinafter referred to as **THE PARTIES**. Hereby agree to jointly create a Cooperation Implementation Plan regarding internship programs, Alumni recruitment program, and the tri dharma of higher education implemented by **THE PARTIES** as regulated in the following article.

Article 1 **PURPOSE AND OBJECTIVES**

- (1) The purpose of this Cooperation Implementation Plan is to serve as a basis for implementing cooperation prepared by **THE PARTIES** in accordance with the scope of this Cooperation Implementation Arrangement.
- (2) The purpose of this Cooperation Implementation Plan is to mutually support the activities **of the PARTIES** in the framework of cooperation related to internship programs, Alumni recruitment program, and the tri dharma of higher education.

SCOPE OF ACTIVITIES

- (1) The scope of this collaborative activity includes student recruitment internships, Alumni recruitment program, and the tri dharma of higher education with the person in charge.

- (2) In implementing this collaborative activity, the Mandarin Language Education Study Program carries out the Go Study with the following rights and obligations.

FIRST PARTY Rights :

- a) get opportunities for students to increase experience and knowledge in areas deemed necessary; And
- b) get the opportunity to participate in discussions, seminars, workshops, the implementation process of which will be arranged later.

SECOND PARTY Rights :

- a) permitted to select students who will carry out internships in accordance with the qualifications **of the SECOND PARTY**;
- b) get the opportunity to become a partner in research, community service, seminars, and so on; And
- c) get the opportunity to recruit **FIRST PARTY alumni**.

ONETH PARTY Obligations :

- a) sending students to carry out internship activities at **the SECOND PARTY's** office, in accordance with the specifications required by **the SECOND PARTY** ;
- b) periodically carry out activities related to the activities **of the SECOND PARTY** which include discussions, seminars, workshops, where the implementation process will be regulated later;
- c) provide information and direction to students to comply with work regulations in force at the **SECOND PARTY office** ; And
- d) carry out *monitoring* and evaluation of activities whose implementation schedule will be agreed in advance with **the SECOND PARTY**.

SECOND PARTY Obligations :

- a) provide experience and knowledge to students in increasing insight according to fields deemed necessary by **the PARTIES** ;
- b) periodically carry out activities related to the activities **of the SECOND PARTY** which include discussions, seminars, workshops, the implementation process of which will be regulated later; And
- c) willing to be invited by **the FIRST PARTY** in order to provide information about the world of business and the world of work from a practitioner's perspective for students or alumni of **the FIRST PARTY** according to the

needs of **the FIRST PARTY**, in the form of presentations, seminars, guest lectures, or other activities.

- d) Intern students will participate in the business processes of the enterprise and get payment.
- e) After graduation, interns can smoothly transfer to fulltime employment by reaching an agreement with the company.
- f) This program provides intern students with the opportunity to study in China, enabling them to broaden their international horizons and enhance their personal skills.

Article 3 FINANCING

The costs for this activity are borne by each **PARTY** in accordance with the existing provisions of each **PARTY's agency** and will be stated in the contract/cooperation implementation plan as an inseparable part of this Cooperation Agreement.

Article 4 TIME PERIOD

The period for Arranging the Cooperation Implementation Plan is from 5 October 2023 to 4 October 2024.


Article 5 CLOSING

- (3) Matters that are not or have not been regulated in the text of this Cooperation Implementation Plan will be regulated later by **the PARTIES** on the basis of deliberation or consensus which will then be stated in an Addendum and is an inseparable part of the Implementation Plan for this Cooperation.
- (4) The Draft Cooperation Implementation Draft is prepared and signed by **THE PARTIES** in 2 (two) copies which have the same legal force.
