This agreement is signed on Monday, 28<sup>th</sup> August, 2023, by the following parties:



**Article 2**  
**SCOPE**

- (2) Providing workshops for lecturers at the Marketing Study Program, Management Faculty of Applied Science and Technology, Universitas Negeri Malang.
- (3) Providing seminars that involve both lecturers and students of the Marketing Study Program, Management Faculty of Applied Science and Technology, Universitas Negeri Malang.
- (4) Providing advice on studying in Malaysia or another country.
- (5) Other duties may arise from time to time assigned by the Marketing Study Program, Management Faculty of Applied Science and Technology, Universitas Negeri Malang.

**FUNDING**



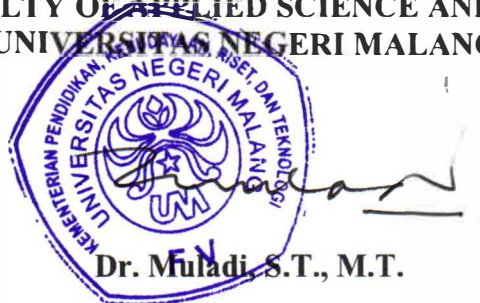
