This Implementation of Agreement for Student Exchange in The Field of Learning with The Theme of Building a Superior School Accountability Management System, Digital Transformation, and Community Participation to Improve the Quality of Primary School Graduates in Indonesia and Thailand is developed and established between THE PARTIES under the following terms:

Article 1 PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop Student Exchange in The Field of Learning with The Theme of Building a Superior School Accountability Management System, Digital Transformation, and Community Participation to Improve the Quality of Primary School Graduates in Indonesia and Thailand between **THE PARTIES**.

Article 2 SCOPE

- (1) The scope of this Implementation of Agreement includes implementation of Student Exchange in The Field of Learning with The Theme of Building a Superior School Accountability Management System, Digital Transformation, and Community Participation to Improve the Quality of Primary School Graduates in Indonesia and Thailand between the lecturers and students of **THE PARTIES**.
- (2) **THE PARTIES** shall monitor the implementation of Student Exchange in The Field of Learning with The Theme of Building a Superior School Accountability Management System, Digital Transformation, and Community Participation to Improve the Quality of Primary School Graduates in Indonesia and Thailand at least twice in 1 (one) year.

Article 4 DURATION

This Implementation of Agreement is effective since 17 Januari 2023 and valid until 17 July 2023.

Article 5 OTHER MATTERS

- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for Student exchange and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
