This agreement is signed on Monday, 28th August, 2023, by the following parties:

- 1. Dr. Madziatul Churiyah, S.Pd, M.M.: Head of the Office Administration Study Program, Management Department; acting on behalf of Office Administration Study Program/Department, Faculty of Economics and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as THE FIRST PARTY.
- 2. Associate Prof. Dr. Fonny Dameaty Hutagalung: a visiting faculty member from Malaysia under the management of Universiti Malaya, located on Lumpur, Malaysia hereby referred to as THE SECOND PARTY.

THE FIRST PARTY and THE SECOND PARTY hereafter shall collectively be referred to as THE PARTIES. This Implementation of Agreement for Teaching Collaboration is developed and established between THE PARTIES under the following terms:

Article 1 PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop staff/lecturers between **THE PARTIES.**

Article 2 SCOPE

- (1) The scope of this Implementation of Agreement includes Teaching Collaboration within the **THE PARTIES**.
- (2) **THE PARTIES** shall monitor the implementation of Teaching Collaboration at least twice in 1 (one) year.

This Implementation of Agreement is effective since 28th August 2023 and valid until 28th August 2028.

Article 5 OTHER MATTERS

- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for teaching collaborations and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
