This agreement is signed on Monday, 28<sup>th</sup> August, 2023, by the following parties:

1. **Dr. Madziatul Churiyah, S.Pd, M.M.:** Head of the Office Administration Study Program, Management Department; acting on behalf of Office Administration Study Program/Department, Faculty of Economics and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. **Associate Prof. Dr. Fonny Dameaty Hutagalung:** a visiting faculty member from Malaysia under the management of Universiti Malaya, located on on 50603 Kuala Lumpur, Malaysia hereby referred to as **THE SECOND PARTY**.

**THE FIRST PARTY** and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Research Collaboration is developed and established between **THE PARTIES** under the following terms:

### Article 1

#### PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop research collaboration between **THE PARTIES** [if the research topic is specific, please mention the topic or area of research].

### Article 2

#### SCOPE

- (1) The scope of this Implementation of Agreement includes research collaboration between the faculty members and students of **THE PARTIES**.

OTHER MATTERS**


- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
