This agreement is signed on Monday, 28th August, 2023, by the following parties:

1. **Dr. Madziatul Churiyah, S.Pd, M.M.:** Head of the Office Administration Study Program, Management Department; acting on behalf of Office Administration Study Program/Department, Faculty of Economics and Business, Universitas Negeri Malang, located on Jalan Semarang 5, Malang, hereby referred to as **THE FIRST PARTY**.
2. **Associate Prof. Dr. Fonny Dameaty Hutagalung:** a visiting faculty member from Malaysia under the management of Universiti Malaya, located on 50603 Kuala Lumpur, Malaysia hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Joint Publications is developed and established between **THE PARTIES** under the following terms:

Article 1
PURPOSE AND OBJECTIVE

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop joint publications between **THE PARTIES**.

Article 2
SCOPE

- (1) The scope of this Implementation of Agreement includes joint publications among faculty members of the **THE PARTIES**.

- (2) **THE PARTIES** shall monitor the implementation of joint publications at least twice in 1 (one) year.
- (3) The joint publications involves several staff/lecturers.

**Article 3
FUNDING**

Funding for the implementation of joint publications mentioned above will be discussed further by **THE PARTIES**. Once agreed, the funding document will be attached as an addendum to this Letter.

**Article 4
DURATION**

This Implementation of Agreement is effective since 28th August 2023 and valid until 28th August 2028.

**Article 5
OTHER MATTERS**

- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for joint publications and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.


