***Faculty of Engineering Universitas Negeri Malang***, Indonesia, which is located at Jl. Semarang No. 5 Malang, here in after referred to as **Faculty of Engineering Universitas Negeri Malang**, and represented in this MoU by its Dean, Dr. H. Andoko, S.T., M.T.

**WITNESSETH**

**WHEREAS**, BIT is a Public Administrative Institution under the Ministry of Labour and Vocational Training, Kingdom of Cambodia for the technical and vocational education and training in the areas of Electricity, Electronics, IT and Graphic Design, Auto Mechanics, Agriculture Machinery, Civil Engineering, Air-conditioner.

**WHEREAS**, Faculty of Engineering Universitas Negeri Malang is a Public Higher Education Institution with one campus in Malang, East Java, Indonesia, and provides Graduate-level education and training and certification in the areas of Informatics and Electrical Engineering, Civil Engineering, Mechanical Engineering, Industrial Technology, and the other study programs that will be opened.

Others


1. The commitment made between the two parties in this agreement is subject to the capability of each party while obeying the agreed rules and regulations.


