

MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITAS NEGERI MALANG (UM)

AND

Robert Bosch Stiftung GmbH

This Memorandum of Understanding (MOU) is made to record the understanding between Universitas Negeri Malang, represented by Rector Prof. Dr. A.H. Rofi'uddin M.Pd., residing in Indonesia, Jalan Semarang No. 5, Malang 65123, Indonesia (hereinafter referred to as "UM"), and Robert Bosch Stiftung GmbH, represented by Mr. Michael Redbrake and Dr. Clemens Spieß, Postfach 10 06 28, 70005 Stuttgart, Germany, (hereinafter referred to as "Robert Bosch Stiftung").

Whereas, UM and Robert Bosch Stiftung agreed to enter into the "Education Partnership" (hereinafter referred collectively as "the Partnership") for the advancement of academic, education development, and humanities to benefit the growth of Indonesia and Germany.

Hereby propose to collaborate with each other to promote the advancement of international understanding, dissemination of learning, and strengthening of cultural ties.

1. MUTUAL INTEREST


The parties share a mutual intent to support and promote the spirit of this MoU by encouraging academic collaboration, including:

- 1.1 Promotion of Lectureship Programme
- 1.2 Development of learning quality (teaching German as a Foreign Language and conducting educational projects)

2. IMPLEMENTATION AND FUNDING

The implementation of the collaborative activities based on this MoU shall be separately negotiated and determined by both institutions and be conducted by way of separate written agreement. Those agreements will set out the Parties' various rights and obligations in respect of the those activities.

The collaborative activities are supported by a cooperation partner, MitOst e.V., Alt-Moabit 90, 10559 Berlin.



Both institutions agree that all specific financial agreements are to be negotiated separately and are dependent on mutual interest and on the availability of funds from both institutions.

3. COMMENCEMENT, RENEWAL, TERMINATION AND AMENDMENT


This Memorandum of Understanding is effective as of the date of execution by the appropriate officer of each signatory institution. It shall remain in force for a period of three (3) years from the date of signing, depending on the successful annual application of the UM for the Lectureship Program and depending on the approval of this application by the Robert Bosch Stiftung GmbH. This MoU may be amended or extended by mutual consent in writing of the two parties.

4. LEGAL ISSUES

Nothing in this MoU will create a legal relationship between the Parties or be legally binding on them. This MoU is to affirm the intent of the Parties to work together in good faith in an attempt to progress the matters described this MoU.




