

MEMORANDUM OF UNDERSTANDING

BETWEEN:

1. **Universitas Negeri Malang/State University of Malang, Indonesia** or known as UM is located in Jl. Semarang No.5, Malang, East Java, Indonesia.
2. **The International Institute of Knowledge Management (Pvt) Ltd** or known as TIIKM, having its registered office at The International Institute of Knowledge Management (Pvt) Ltd, #531/18, Kotte Road, Pittakotte, Sri Lanka.

(Universitas Negeri Malang and TIIKM together, the “Parties” and each, a “Party”).

BACKGROUND:

- (A) Party 1: Universitas Negeri Malang, formerly the Teacher Education College and Educational Sciences of Malang, is one of the state universities in Indonesia. Located in Malang and Blitar, East Java, UM was established in October 18, 1954 as PTPG Malang, as School of Education of Airlangga University, making it one of the oldest teaching institutes in Indonesia. UM was separated from Airlangga University on 20 May 1964 to become IKIP Malang. In 1999, IKIP Malang formally changed its status from an institute to a state university.
- (B) Party 2: The International Institute of Knowledge Management (TIKM) is a premier research institute that is entrenched in serving the purpose of knowledge transfer by constructing the careers of researchers and bring upon a new revolution in the Asian research culture. TIKM brings out exclusive knowledge experience to academics, researchers, scholars and professionals across the world who explores knowledge and skills in order to succeed in their career and conquer the world.
- (C) The Parties recognise the capabilities and resources that each Party brings, and agree to use their best efforts to collaborate to:
1. Support the success of the **5th International Conference on Education (ICEDU '19)** to be held in 4th – 7th April 2019 in **Kuala Lumpur, Malaysia**.
 2. Facilitate an effective platform to share the knowledge in education, whilst empowering participants through providing a solid platform for them to present their research findings to a global audience.

OPERATIVE PROVISIONS:

1. Objective

- 1.1 The objective of this non-exclusive collaboration is to allow Universitas Negeri Malang, Indonesia to *collaborate as the Academic Partner for the 5th International Conference on Education (ICEDU '19)* to be held in 4th – 7th April 2019 in *Kuala Lumpur, Malaysia*.

2. Non-binding nature and relationship

- 2.1 This MOU is not intended to constitute or create a joint venture, agency, employment or similar enforceable arrangement between the Parties. No Party has any right or authority to make or undertake any promise or to make any representation for the

other Parties, or to execute any document or to otherwise assume any obligation or responsibility in the name of or on behalf of the other Parties.

3. Negotiations and Discussions

3.1 The Parties shall, through their respective nominated representatives, as soon as practicable after signing this MOU, use their best endeavours to further negotiate and discuss in good faith, to enable each Party to evaluate fully its interest in collaborating in the proposed programs set out in this MOU.

3.2 The negotiations referred to in clause 3.1 shall, without limitation, include discussions with regard to the scope of the various activities between Parties including timeframes, milestones and project management.

4. Universitas Negeri Malang, Indonesia Contribution

4.1 Universitas Negeri Malang, Indonesia agrees to contribute to the collaboration by making the following contributions:

1. Authority to use the university logo in the conference website and all other promotional materials.
2. Provision of 3 – 5 University representatives to the Scientific Reviewing Committee.
3. Educating the students on the Conference encouraging to submit researches as a means of promoting the research culture in the University.
4. Listing of the Conference in the University website and promoting among the University affiliations.

5. The International Institute of Knowledge Management (Pvt) Ltd's Contribution

5.1 **TIKM** agrees to support the collaboration by making the following contributions:

1. Two complimentary registrations for the nominated persons from Universitas Negeri Malang, Indonesia
2. Special discounted rates for the registration fee for the participants of Universitas Negeri Malang, Indonesia
3. Opportunity to project the University's vision in an International arena

6. Term and Termination

- 6.1 This MOU will enter into force on 01.06.2018 (The "Effective Date") and expire on 01.06.2019. The Parties hereby agree that all work undertaken in connection with the matters contemplated in this MOU shall be governed by the terms and conditions of this MOU notwithstanding that it took place prior to the Effective Date.
- 6.2 The MOU may be extended by mutual written agreement of the Parties. Any Party may terminate this MOU at any time with 1 month prior written notice to the other Parties, with or without cause, and without liability of any kind to the other Parties.
- 6.3 The termination of this MOU shall not prejudice programmes or projects already undertaken pursuant to the MOU prior to such termination. On termination of this MOU, each Party agrees to return all properties (e.g. content, technology, software, documentation etc) owned or provided by the other Parties.

7. Confidentiality

- 7.1 The Parties including its officers, agents and authorized representatives shall not disclose, use or communicate to any person any confidential information of the other Party and not otherwise publicly available nor known by the recipient at the time of disclosure.
