KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (“Agreement”) is executed on January 28, 2016 by and between:

AND

THE GRADUATE SCHOOL OF UNIVERSITAS NEGERI MALANG, the graduate school of a leading university duly organized under the laws of Indonesia, with its principal place of business at Jalan Semarang 5, Malang, Indonesia, represented herein by its Director, **PROF. DR. I NYOMAN SUDANA DEGENG** (hereinafter referred to as “PPs UM”);

WITNESSETH THAT:

WHEREAS, **PPs** through its own efforts, government support and commitment, has established an excellent reputation for world class education in a variety of undergraduate and graduate courses;

WHEREAS, **PPs UM** proposes **BU** to conduct three customized master’s courses specialized in Economics-related Topics to the Customized English Department Students of The Mater’s Program of **PPs-UM** (collectively referred to as Master’s Students);

NOW, THEREFORE, and in consideration of the mutual understanding and commitments set forth in this Agreement, the Parties hereto agree as follows:

1) **GENERAL FRAMEWORK FOR THE PROGRAMS**

- b) Number of Students: 33 Students
- c) Duration : 4 Weeks

2) **TERM**

This Agreement shall be for a period of two (2) years commencing from date of execution thereof, unless terminated earlier by mutual consent of the parties, or with one month prior notice to the other party on the ground of material breach of any of the provisions of this Agreement without justifiable cause.
