MEMORANDUM OF UNDERSTANDING BETWEEN

FACULTY OF ENGINEERING, UNIVERSITAS NEGERI MALANG AND

THE DEPARTMENT OF INDUSTRIAL EDUCATION, NATIONAL TAIWAN NORMAL UNIVERSITY

Faculty of Engineering, Universitas Negeri Malang, Indonesia and the Department of Industrial Education, National Taiwan Normal University, Taipei, Taiwan R.O.C., hereby agree to foster academic exchange and cooperation between the two institutions.

SCOPE OF COOPERATION

Subject to mutual consent, the areas of cooperation will include any program offered by either institution as felt desirable and feasible on either side and that contributes to fostering and development of the cooperative relationship between the two institutions.

Cooperation may be carried out through such activities as:

- Exchange of faculty and/or staff;
- Exchange of students;
- Exchange of scientific materials, publications, and information of common interest;
- Exchange of cultural activities
- Joint conferences and academic programs;
- Joint research activities and publications;
- Any other areas of cooperation to be mutually agreed upon the Parties.

These activities are to be carried out after mutual consultation between the two institutions or the divisions concerned thereof. Normally each institution will sign a letter of agreement setting out the responsibilities of each institution for the agreed activity and such other matters as the institutions agree are necessary for the efficient achievement of the activity.

FUNDING

- 1. This Memorandum of Understanding will not give rise to any financial obligation by one Party to other.
- 2. Each Party will bear its own cost and expenses in relation to this Memorandum of Understanding, unless agreed by both Parties.

EFFECT OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, and is not intended to constitute or create, obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

INTELLECTUAL PROPERTY RIGHTS, RESULTS, AND PUBLICATIONS

Each party shall continue to remain the sole owner of its material contributed to any joint project. Arrangement relating to new intellectual property rights jointly created, results and rights of publication shall be agreed in writing.

SETTLEMENT OF DIFFERENCES

If dispute arise then with the consent of both parties such dispute shall be resolved through negotiation.

AMENDMENTS, RENEWAL, AND TERMINATION

This Memorandum of Understanding may be modified through the mutual discussion and consent of the two institutions and shall remain in effect from the date of signature for an initial period of three years. The validity of the agreement may be renewed after mutual consultation and written approval from both parties. Two copies of this Memorandum shall be signed and each Party keeps one for record, both having same legal validity. This Memorandum of Understanding may be terminated by a party on six month written notice to the other.
