



**MEMORANDUM OF UNDERSTANDING
BETWEEN
INTERNATIONAL CULTURAL COMMUNICATION CENTER
(ICCCM), MALAYSIA
AND
UNIVERSITAS NEGERI MALANG (UM), INDONESIA**

In order to promote human resource development through education, academic exchange and cooperation; International Cultural Communication Center (ICCCM) and Universitas Negeri Malang (UM) agree to sign the Memorandum of Understanding (MoU), details are following:

Article I: Purpose

The purpose of this MoU is to develop academic and educational cooperation on the basis of equality and reciprocity and to promote relations and mutual understanding between both institutions.

Article II: Scope of the Academic Exchange and Educational Cooperation

- a) Mutual visits for staff, teachers and students;
- b) Facilitating and cooperating in finding scholarships for students, students' short-term study, and extension of students' learning opportunities;
- c) Cooperation in providing new academic program to meet job requirement and investment growth with mutual interests to both institutions;
- d) Cooperative recruitment and cultivation for students;
- e) Facilitating and cooperating for teachers' exchange and training;
- f) Jointly-held academic and teaching seminars;
- g) Cooperation in research and the presentation of its results;
- h) Facilitating and cooperating for the exchange of academic materials, publications and other scientific information between ICCCM with partner universities;
- i) Other educational and academic cooperation to which both institutions agree.

Article III: Principles of Implementation

- a. All specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds. Both parties should feasibly seek financial support from national and international organizations for the cooperative activities to be undertaken as stated under the terms of this MoU;
- b. The ICCCM should facilitate and coordinate with partner universities to implement the MoU effectively;
- c. Mutual visits of teachers/students and other collaboration plans can be discussed annually;
- d. Scientific research projects, jointly-held academic meetings, teaching seminars and other agreed plans would be discussed separately;

Article IV: Settlement of Differences

The differing viewpoints and interpretations of this MoU shall be settled amicably by mutual consultation or negotiation.

Article V: Amendments, Duration and Termination

1. Amendments to this MoU can only be made by mutual consent for the two parties.
2. This MoU shall be in effect from the date of its signature and be valid for the duration of three (3) years from that date, and will be automatically renewed on an annual basis thereafter, unless terminated or replaced with a new MoU.
3. This MoU may be terminated by either party by written notice at least three (3) months prior to the termination date. Such notice of termination will not interfere with cooperative programs currently underway. Such programs will be allowed to continue until their conclusion.

Article VI: Notice

Every notice, request or any other communication required or permitted to be given pursuant to this Agreement shall be in writing, in English and delivered personally or sent by registered or certified air mail or by courier or fax (which shall be acknowledged by the other Party) to the Parties at the addresses as stated below:



