WHEREAS, **the ALLIANCE OF TEACHERS FOR INNOVATIVE EDUCATION AND EXCELLENCE INC.** a non-profit organization composed of faculty with varied field of specialization in the Mindanao State University and at the Department of Education, Philippines and in its concern to enhance the knowledge, skills, attitudes, pedagogy, and values of teachers and students in the field of education, research, conferences and trainings, has instituted this Memorandum of Agreement.

2. Conduct a joint or in cooperation of various international conferences, trainings, and seminar workshops in the field of research, content knowledge enhancement and teaching pedagogies.
3. **Research**, Conferences, Trainings, and Seminar workshops will be conducted both in Indonesia or Philippines and at the future to other neighbouring countries.
4. Conduct a joint or in cooperation of publications including journals and books.


This AGREEMENT shall hold for the duration of _____ (years) and is automatically renewable provided that **ALLIANCE OF TEACHERS FOR INNOVATIVE EDUCATION AND EXCELLENCE INC.**, and **FACULTY OF EDUCATION IN STATE UNIVERSITY OF MALANG** reserve their respective rights to withdraw their participation in the agreement upon written notice.


