

**PUBLICATION AGREEMENT
BETWEEN
UNIVERSITAS NEGERI MALANG
AND
YOUNG WISE PUBLISHING**

The **UNIVERSITAS NEGERI MALANG/STATE UNIVERSITY OF MALANG**, a university established under the laws of Indonesia and having an address at Jl Semarang No. 5, Malang 65145, Indonesia (hereafter referred to as “UM”) as the part one;

AND

The **YOUNG WISE (GENÇ BILGE) PUBLISHING** was established in Düzce University Teknopark A.Ş. in 2015 as a sole proprietorship. Then as a limited company “Genç Bilge Yayıncılık Ltd. Şti.” 17.04. 2017 as an entrepreneurial company in IAU Incubation with its name was established in 2017 and since June 2021 established in London, UK as other part;

The Parties agreed to have a collaboration in the field of publication with the term as follows:

1. Kind of publications

The Part One and the Other Part agreed to have collaboration in the publication of six (6) journals published by Young Wise Publishing as follows: a. Journal of Gifted Education and Creativity (JGEDC)

b. Psychology Research on Education and Social Sciences (PRESS)

c. Journal for the Education of Gifted Young Scientists (JEGYS)

d. Journal for the Child Development, Exceptionality and Education (JCDEE)

e. Journal for the Mathematics Education and Teaching Practices (JMETP)

f. Journal for the Interdisciplinary Art and Education (JIAE)

2. Period and number of publications

Period of publication follows the period of journals published by Young Wise Publishing. Each period of publications, the Part one sends two (2) articles for each journal that will be published.

3. Eligibility of publication

Eligibility of publication follows the term and condition from the publisher

4. Responsibilities of each part

The Part one sends two articles in every periodical journal and the Other part receives and publishes articles.

5. Funding

Funding for the collaboration in publication is fulfilled by the Part One as the term of publication fee in each journal published by the Other Part.

6. Effective Date and termination of agreement

This agreement shall be effective on and after the date of its signing by the authorized representatives of both parties and remain in force for a period of two (2) years. Thereafter this agreement shall be renewed on a year-to-year basis or for a further period to be mutually agreed upon in writing by the parties.

Either party may terminate this agreement at any time by serving written notice to other party at least three (3) months before the date of such termination. Notwithstanding such termination each Party agrees to carry out any negotiations and responsibilities assumed prior to the termination date.

7. Amendments or Modifications

No amendments, modifications, supplements, termination, or waiver of any provision of this agreement will be effective unless made in writing and duly signed by both Parties.

8. Notices

Every notice, request, or any other communication required or permitted to be given pursuant to this agreement shall be in writing, in English and delivered personally or sent by registered or certified air mail (which shall be acknowledged by other Party) to the Parties at the addresses stated below:

Dispute, controversy, or claim arising out or relating to this Agreement, or the termination of invalidity there to shall be solved amicably by both parties, failing which either party may take the dispute, controversy, or claim to any competent court of law in Indonesia or Turkey.

11. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Indonesia and Turkey.
