BACKGROUND

University Performance Indicators are an important part of the strategic plans of the State University of Malang (UM) and UniKL. Performance achievement serves as a parameter to measure the success of the University during a certain period. In the current era of globalization, the performance indicators of a university are not only assessed nationally, but also internationally. With the increasing competition, universities must be able to show competitiveness both nationally and globally, one of which is by becoming a World Class University. In accordance with current developments, the internationalization of universities is a very urgent thing to do. University internationalization is a process that integrates the international component into the university in the purpose, function or delivery of education (including curriculum development and innovation; exchange of lecturers, staff and students, development and expansion of study programs; use of technology assistance for learning, training culture, education for international students; and research/co-publication)

1. Increase the university's relevance to the needs of the world of education and the world of work.
2. Providing space for universities to choose the advantages they want to develop.
3. Prioritizing university goals so that they can focus on adapting and pursuing important changes that occur.



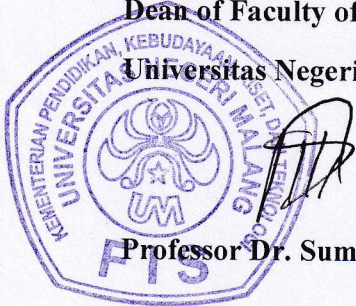
