



MEMORANDUM OF AGREEMENT BETWEEN STATE UNIVERSITY OF MALANG, INDONESIA AND WALAILAK UNIVERSITY, THAILAND

This Memorandum of Agreement is made and executed between:

The Faculty of Letter, the State University of Malang, represented herein by DR. ROEKHAN, M.PD, Vice Dean II, the Faculty of Letter, herein after referred to as the FIRST PARTY,

And

The School of Liberal Arts, Walailak University, represented herein by ASST. PROF. DR. NIBONDH TIPSRINIMIT, Dean, the School of Liberal Arts, hereinafter referred to as the SECOND PARTY.

Witnesseth, that:

The Parties hereby bind themselves to undertake a Memorandum of Agreement for the purpose of developing the knowledge and skills of Indonesian Language and Indonesian Studies for the students of ASEAN Studies Program, the School of Liberal Arts, Walailak University, under the following terms and conditions:

- 1. The FIRST PARTY shall be responsible for providing courses on Indonesian Language and Indonesian Studies for the ASEAN Studies Program's students who intend to study at the State University of Malang for the full academic year as part of the SECOND PARTY's curriculum;
- 2. The courses provided by the FIRST PARTY, upon consultation with the SECOND PARTY, shall be regular courses which are taught to the FIRST PARTY's undergraduate students. The ASEAN Studies Program's students shall be allowed to register for courses and study with their Indonesian counterparts;

- At the end of the academic year, the FIRST PARTY shall send the SECOND PARTY
 the official academic record of each student and credits will be given according to the
 regulations of Walailak University;
- 4. Tuition and any other study-related fees for ASEAN Studies Program's students shall be based on the prevailing regulations and mutual agreements between the State University of Malang and Walailak University;
- 5. Studies Program's students shall be responsible for securing their own accommodation. Assistance will be provided by the FIRST PARTY to locate appropriate accommodation. On-campus accommodation shall be provided subject to availability;
- 6. The SECOND PARTY shall provide the ASEAN Studies Program's students adequate Indonesian proficiency and the basic orientation on behavior and discipline to ensure smooth cooperation with the FIRST PARTY;
- 7. This Agreement will become effective upon signing by the parties and will commence at the start of the 2019 academic year. Unless otherwise advised in writing by either party, this Agreement shall automatically be renewable for the same period under the same terms and conditions.
