



**MEMORANDUM OF AGREEMENT
INTERNSHIP PROGRAM FOR UNDERGRADUATE STUDENTS**

Following the proposed signing of a Memorandum of Agreement between Universitas Negeri Malang, Indonesia, and the Association of Education Cultural International, Thailand, the Faculty of Letters, Universitas Negeri Malang (UM), and the Association of Education Cultural International (AECI), Thailand believe that mutual benefits can be obtained by bridging both parties, achieved a closer relationship with the internship for undergraduate students. Both of them have a strong conviction that mutual understanding between people can be promoted through the internship program for undergraduate students. Therefore, both of them agreed to sign this Memorandum of Agreement (MoA) regarding the internship program for undergraduate students.

Article I: Principle of Collaboration

Faculty of Letters, UM, and the Association of Education Cultural International (AECI) agree to internship for undergraduate students under the principle of mutual understanding, mutual benefits, common interests, and mutually complementary activities.

Article II: Aims of Collaboration

- 1) To promote individual contacts among students and personnel of both;
- 2) To promote links in the study and cultural activities;
- 3) To encourage any other activities that both agree will be of mutual benefit.

Article III: Areas of Collaboration

Areas of collaboration are the internship for undergraduate students.

Article IV: Implementation

It is understood and agreed that:

5) Funding during the internship activities is regulated as follows:

- a) Transportation costs are the responsibility of the student. In this case, the Faculty of Letters, UM, provided financial assistance to purchase travel tickets to Muang Krabi.
- b) Funding for accommodation while students are in Thailand is the responsibility of the institution where the students undertake the internship.
- c) Tuition fees are paid as usual to the home campus, *Universitas Negeri Malang*.
- d) The institution where students are apprenticed is not required to provide any salary or honorarium to students as a form of appreciation for their internship activities.
- e) The institution where the student interns will send a student performance report to the Dean of the Faculty of Letters, UM, as an evaluation of the student's internship performance.
- f) Faculty of Letters, UM, or the institution where the student interns not be responsible to cover the costs of medical treatment or hospitalization for visiting staff or students, and it is recommended that visitors should obtain overseas health insurance coverage from their home country.

Article V: Duration and Termination of the Agreement

- 1) This MoA is effective as of the date of signature by the two sides until six months after.
- 2) This MoA may be terminated by either side by the provision of a written notice of termination first. However, both agree that at that time all continuing obligations to students, staff, funding bodies, or other entities are met in full subsequent to the notice of termination.

Article VI: Notices

Every notice, request, or any other communication required or permitted to be given pursuant to this agreement shall be in writing, in English, and delivered personally or sent by registered or certified air mail or by courier or fax to both sides at the addresses as stated below:

Dispute, controversy, or claim arising out or relating to this agreement, or the termination or invalidity thereto shall be solved amicably by both parties by discussion to reach a consensus. Should consensus be not reached from the discussion, either party may take the dispute, controversy, or claim to the Foreign Affairs in each country to find a solution through diplomacy.



Article IX: Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Indonesia and Thailand.
