Article 4

OTHER MATTERS

- (1) This Letter can be changed or modified upon mutual agreement in writing of THE PARTIES under mutually agreed terms and conditions.
- (2) This Letter shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Letter shall be discussed by **THE PARTIES** and can be written in an Addendum attached to this Letter.
- (4) This Letter is developed for collaboration and is established and signed by **THE**PARTIES in duplicate; all copies being equally authentic.
