**Pasal 1  
TUGAS PEKERJAAN**

Pihak Pertama atas nama Rektor Universitas Negeri Malang memberi tugas kepada Pihak Kedua untuk menggunakan dana yang tertuang dalam perjanjian ini sebagai biaya *Program Indonesian Flagship Language Initiative* Tahun 2018 yang diselenggarakan di Fakultas Sastra Universitas Negeri Malang.

**Pasal 2  
WAKTU PELAKSANAAN**

Waktu pelaksanaan kegiatan oleh pihak kedua mulai bulan Agustus 2018 sampai dengan bulan November 2018.

**Pasal 3  
BIAYA KEGIATAN**

Biaya pelaksanaan kegiatan tersebut pada pasal 1 yang harus dibayar oleh Pihak Pertama melalui BPP / PUMK Kerjasama kepada Pihak Kedua sebesar Rp. 1.155.248.600,- (Satu milyar seratus lima puluh lima juta dua ratus empat puluh delapan ribu enam ratus rupiah) dibebankan pada DIPA Universitas Negeri Malang Tahun 2018.

**Pasal 4  
PEMBAYARAN**

Pembayaran biaya kegiatan dilakukan setelah surat tagihan pembayaran kegiatan dibayarkan oleh *American Council for International Education* kepada Bendahara Penerimaan Universitas Negeri Malang yaitu sebesar sebesar Rp. 1.155.248.600,- (Satu milyar seratus lima puluh lima juta dua ratus empat puluh delapan ribu enam ratus rupiah)

**Pasal 5  
PAJAK DAN MATERAI**

- (1) Pihak Kedua melalui BPP / PUMK Kerjasama bertanggungjawab sepenuhnya atas pelunasan pajak-pajak sesuai ketentuan perundangan yang berlaku.
- (2) Bea materai tunggal Rp 6.000,00, ditanggung oleh Pihak Kedua.

**Pasal 6  
LAPORAN**

- (1) Pihak Kedua melalui BPP / PUMK Kerjasama berkewajiban menyampaikan laporan penggunaan dana dilampiri bukti pertanggungjawaban penggunaan dana sebagaimana tersebut pada pasal 3 kepada pihak pertama paling lambat 15 hari setelah batas waktu penggunaan dana.
- (2) Bukti Surat Pertanggungjawaban disimpan dan dibukukan oleh BPP / PUMK Kerjasama atas nama Pihak Pertama untuk keperluan pemeriksaan Auditor.

**Pasal 7  
SANKSI**

- (1) Apabila Pihak Kedua tidak memenuhi perjanjian sebagaimana tersebut pada pasal 1, maka Pihak Kedua berkewajiban mengembalikan biaya kegiatan sebagaimana pasal 3 kepada Pihak Pertama.
- (2) Penyimpangan atas penggunaan dana sebagaimana pada pasal 3 sepenuhnya menjadi tanggungjawab Pihak Kedua.

**Pasal 8  
LAIN-LAIN**

Perjanjian yang belum diatur dalam perjanjian pelaksanaan kegiatan ini akan ditentukan kemudian oleh kedua belah pihak.


**Pasal 9





**SCOPE OF WORK  
AS AGREED UPON BY  
UNIVERSITAS NEGERI MALANG  
MALANG, INDONESIA  
AND  
AMERICAN COUNCILS FOR INTERNATIONAL EDUCATION**

The following Parties, the State University of Malang or Universitas Negeri Malang (hereinafter referred to as UM), represented by Prof. Dr. Ahmad Rofi'uddin, Rector, and American Councils for International Education (hereinafter referred to as American Councils), represented by David Patton, Executive Vice President, enter into the following Agreement:

**1. OBJECTIVES**

American Councils, as the official administrator of the 2018 Indonesian Flagship Language Initiative (IFLI) Program, commissions the aforementioned Institution to teach students participating in the IFLI program in compliance with the curriculum developed and approved by both Parties.

**2. RIGHTS AND OBLIGATIONS OF THE PARTIES**

**2.1 UM agrees to:**

- 2.1.1 Teach program participants advanced Indonesian in accordance with the goals and philosophy of the IFLI Program as outlined in the terms and conditions of this Agreement and with a team of full time instructors who are dedicated solely to the IFLI Program;
- 2.1.2 Organize cultural events and outings for program participants;
- 2.1.3 Provide educational materials (books and other materials) to program participants;
- 2.1.4 Recruit and assign Language Partners to program participants in consultation with the IFLI Resident Director;
- 2.1.5 Assist with identifying internships for program participants in the spring semester;
- 2.1.6 Provide program participants and American Councils representatives with visa support and support for residence. UM provides necessary documentation, and any fees are the responsibility of the student or American Council representative;
- 2.1.7 In coordination with American Councils' Resident Director, conduct in-program orientation for the participants, as well as for host families.
- 2.1.8 Serve as liaison between students and host families;
- 2.1.9 Host families will provide meals to program participants throughout the week.
- 2.1.10 Issue a letter of enrollment verification at the beginning of the semester.
- 2.1.11 Issue a certificate and a transcript of grades for each program participant at the end and upon successful completion of the Program.

**2.2 American Councils agrees to:**

- 2.2.1 Arrange program participants' international travel to and from the city where UM is located;
- 2.2.2 Provide program and administrative guidance and oversight in cooperation with UM;
- 2.2.3 Provide oversight of program participants;
- 2.2.4 Provide a full-time Resident Director who serves as the American Councils representative. The Resident Director serves as academic and personal counselor for

program participants and as a liaison between American Councils and UM administration, observes student classes and meets regularly with teachers, administrators, and students. The Resident Director will be available to participants during any emergencies that arise.

- 2.2.5 Provide a full-time Academic Coordinator who will be responsible to ensure that students receive productive and organized instruction appropriately geared to their proficiency levels, serve as an expert teacher, advise and direct individual faculty members in developing appropriate classroom materials, textbooks, organizing classroom meetings, planning weekly assignments, expanding communicative teaching methods, and finding new, creative approaches to coursework. The Academic Coordinator will regularly visit classes to observe teaching methods and to help faculty develop new teaching methods as needed.
- 2.2.6 Remit payments for tuition, program operations and the cultural program in accordance with the fees stipulated in this Agreement.

### **3. TERMS AND CONDITIONS OF THE ACADEMIC PROGRAM**

- 3.1 UM agrees to the following:
  - 2.2.1 Provide Indonesian language classes to program participants in keeping with the agreed upon schedule including group lessons and individual lessons with Language Partners (each participant receives roughly 20 hours of classroom instruction and 4 hours of individual instruction per week.)
  - 2.2.2 Accommodate varied language proficiency levels by planning instruction accordingly, providing individual support, or by assigning students to groups according to their proficiency level.
- 3.2 Participants have the right to withdraw from the program due to unforeseen circumstances such as illness, emergency departure, etc.
- 3.3 Participants have the right to use all facilities available at UM during opening hours.
- 3.4 All other provisions not stipulated in this Agreement, shall be in accordance with UM admission and study policies.

### **4. TUITION RATES AND BILLING**

Payment to UM will be provided upon receipt of reflecting the cost categories as outlined in the budget (Attachment 1), and approved and signed by UM's appropriate administrative official. Payment shall be made in US dollars to an account designated by UM, and remittance charge shall be borne by American Councils.

In case of a participant withdrawal, unspent funds will be returned to American Councils.

Payment will be made at least 2 weeks before the beginning of the program upon receiving the invoice.

Any other adjustments (e.g., costs of new services requested, will be negotiated by UM and American Councils.

### **5. TERMS OF THIS AGREEMENT**

The Agreement will take effect on August 10, 2018, and will remain in effect until November 30, 2018, unless extended by mutual agreement.

Both parties agree to the document by signing two copies in English.




