The amount of funding for this guest lecture is charged to each **PART**, which originates from study program/ university.



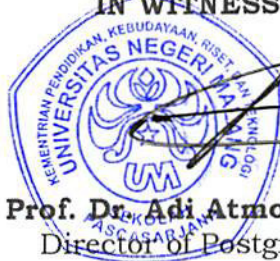
