2. Associate Prof. Dr. Muhammad Faizal Bin A. Ghani: Head of Department of Educational Management, Planning and Policy, Faculty of Education, University of Malaya; acting on behalf of Department of Educational Management, Planning and Policy, University of Malaya located on St. Profesor Diraja Ungku Aziz, Seksyen 13, 50603 Kuala Lumpur, Wilayah Persekutuan Kuala Lumpur, Malaysia hereby referred to as **THE SECOND PARTY**.

THE FIRST PARTY and **THE SECOND PARTY** hereafter shall collectively be referred to as **THE PARTIES**. This Implementation of Agreement for Joint Publications is developed and established between **THE PARTIES** under the following terms:

Article 1 **PURPOSE AND OBJECTIVE**

- (1) The purpose of this Implementation of Agreement is to support collaboration between **THE PARTIES** within the scope of this agreement mentioned in Article 2.
- (2) The objective of this Implementation of Agreement is to develop joint publications between **THE PARTIES**.

Article 2 **SCOPE**

- (1) The scope of this Implementation of Agreement includes joint publications among faculty members of the **THE PARTIES**.

- (2) **THE PARTIES** shall monitor the implementation of joint publications at least twice in 1 (one) year.
- (3) The joint publications involves 8 (Eight) lecturers.

FUNDING**

**Article 4
DURATION**

This Implementation of Agreement is effective since 7th November 2022 and valid until 7th November 2024.


**Article 5
OTHER MATTERS**

- (1) This Implementation of Agreement can be changed or modified upon mutual agreement in writing of **THE PARTIES** under mutually agreed terms and conditions.
- (2) This Implementation of Agreement shall be terminated when one of **THE PARTIES** or **THE PARTIES** violate the mutually agreed terms and conditions.
- (3) Other matters outside this Implementation of Agreement shall be discussed by **THE PARTIES** and can be written in an Addendum attached as an integral part of this Implementation of Agreement document.
- (4) This Implementation of Agreement is developed for joint publications and is established and signed by **THE PARTIES** in duplicate; all copies being equally authentic.
