



MEMORANDUM OF AGREEMENT INTERNSHIP PROGRAM FOR GRADUATE STUDENTS

Following the proposed signing of a Memorandum of Understanding (MoU) between Universitas Negeri Malang, Indonesia, and Attarkiah Islamiah Institute, Narathiwat, the Faculty of Letters, Universitas Negeri Malang (UM), and the Attarkiah Islamiah Institute, believe that mutual benefits can be obtained by bridging both parties, achieved a closer relationship with the internship for graduate students. Both of them have a strong conviction that mutual understanding between people can be promoted through the internship program for graduate students. Therefore, both of them agreed to sign this Memorandum of Agreement (MoA) regarding the some program for graduate students.

Article I: Principle of Collaboration

Faculty of Letters, UM, and Attarkiah Islamiah Institute agree to collaboration under the principle of mutual understanding, mutual benefits, common interests, and mutually complementary activities.

Article II: Aim of Collaboration

- 1) To promote relationship between students and lecturers of Faculty of Letters, Universitas Negeri Malang with students and teachers in Attarkiah Islamiah;
- 2) To promote links in the study and cultural activities;
- 3) To encourage any other activities that both agree will be of mutual benefit, like internship and community service.

Article III: Areas of Collaboration

Areas of collaboration are the internship and community service for students and lecturers.

Article IV: Implementation

It is understood and agreed that:

- 1) Proposals for collaborative projects under this MoA will be submitted through the Chief Executive Officer of either side or both sides, and it is recommended that reports should be submitted to each Chief Executive Officer at the completion of each project.
- 2) Student mobilization will apply to undergraduate and graduate students from UM and include internship and community service. After the period of study, the host institution will send academic transcripts of the student's work to the appropriate officer of the home institution.
- 3) Financial arrangements for internship and community service, and other such activities will be negotiated separately and will be subject to the availability of funds.
- 4) Faculty of Letters, UM, or the institution where the student interns not be responsible to cover the costs of medical treatment or hospitalization for visiting staff or students, and it is recommended that visitors should obtain overseas health insurance coverage from their home country.
- 5) Both agree to assist each other in encourage any other activities that both agree will be of mutual benefit.

Article V: Duration and Termination of the Agreement

- 1) This MoA is effective as of the date of signature by the two sides until four year after.
- 2) This MoA may be terminated by either side by the provision of a written notice of termination first. However, both agree that at that time all continuing obligations to students, staff, funding bodies, or other entities are met in full subsequent to the notice of termination.

Article VI: Notices

Every notice, request, or any other communication required or permitted to be given pursuant to this agreement shall be in writing, in English, and delivered personally or sent by registered or certified air mail or by courier or fax to both sides at the addresses as stated below:

Dispute, controversy, or claim arising out or relating to this agreement, or the termination of invalidity thereto shall be solved amicably by both parties by discussion to reach a consensus. Should consensus be not reached from the discussion, either party may take the dispute,

controversy, or claim to the Foreign Affairs in each country to find a solution through diplomacy.

Article IX: Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Indonesia and Thailand.
